- Describe how a grant to your organization relates to the Mission of the Friars Charitable Foundation.
- Statement of Need: Describe need that the project/program will address.
- Overview of your programs:
 - Measurable goals and objectives;
 - Description of activities (what you will actually do and how do these activities address the previous the previous statement of need);
 - Description of the organization's constituency (who will be served/impacted by your work).
- Overview of how your work is evaluated:
 - Description of how success is defined and measured by your organization.
